S. No. 1 Clause: 1.1.1 Eligibility Criteria Bidder's Query: (i) To prove an experience in private client, TDS certificate is asked. But TDS is not applicable on Uniform (material) bills. Therefore, this condition should be waived off in Note-1. (ii) In Note-2, the value of completed portion of work till published date of tender should be considered. MMMOCL Remarks: Clause 1.1.1 amended, as per Corrigendum-1. S. No. 2 Clause-5.7 Bidder's Query: The delivery period and the slabs for the delivery of uniforms are not mentioned in Tender Document. MMMOCL Remarks: Clause -5.7 mentioned the delivery period. This clause has been amended for better clarity, as per Corrigendum-1. S. No. 3 Clause- 6.2 Bidder's Query: Weave and fabric specification in detail are not mentioned in Tender Document. MMMOCL Remarks: Clause 6.2 amended, as per Corrigendum-1.
