Whether it will be in order to take CAR Policy (Contractor's All Risk Insurance Policy) from New India Assurance Co Ltd since this is being accepted by MMRDA for other Tenders.	The tender Clause no. 2.18 is adequately clear. No further clarification is considered necessary.
2	Appendix -1, Pg. 104, Power of Attorney.	Whether the Power of Attorney to be submitted on plain paper or stamp paper?	Power of Attorney is to be submitted on Stamp paper only. The tender Clause - 4.76 (ii) is adequately clear. No further clarification is considered necessary.
3	Appendix -8, Pg. 114, Price Bid - Schedule A.	What about the mandatory leave of 23 days as per Maharashtra State Minimum Wages Act? Whether the proposed contract staff can take the said leave? If yes, then what about the reliever?	The tender Clause no. 4.117 is adequately clear. No further clarification is considered necessary. MMMOCL will not reimburse the cost of reliver.

4	Appendix -8, Pg. 114, Price Bid - Schedule A.	In case of any increase of Minimum wages which is happens on every January and July, whether the difference can be claimed?	The tender Clauses – 4.117 and 5.1 are adequately clear. No further clarification is considered necessary.
5	Appendix -8, Pg. 115, Price Bid - Schedule B.	It is mentioned that "Any of the items listed in Delhi Schedule of Rates (DSR) 2021, CWD (for One year) as per instruction of the Engineer / requirement of MMMOCL" to be provided by the Bidder. However, no clarity is given. Items mentioned in DSR is very vast (containing 337 pages). Attaching Page, No IX & X giving Schedule details. Need some clarity about the requirements i.e. from which sub-head, the requirements will be asked by MMMOCL out of 28 sub-head of items to avoid confusion in future.	Items listed in the Delhi Schedule of Rates (DSR) 2021, CWD may be operated by the Engineer as per work requirement, within the BOQ amount prescribed, and paid as per actuals. The tender Clause – 7.5 is adequately clear. No further clarification is required.
6	Appendix-3, pg. 106, Form of Bank Guarantee Bond for Performance Security	Whether the Bank Guarantee to be submitted while submitting the tender?	The successful bidder will have to submit a Performance Bank Guarantee as per Article 5(i) at page 129 of tender document in the proforma given at Appendix-3. The Appendix-3 is adequately clear. No further clarification is required.

MMMOCL has clarified above queries submitted by the representatives of various companies who attended the Pre-bid Meeting on 9th November, 2021. For any query/ clarification/ additional information to any Clause not covered above, MMMOCL has decided to retain such Clause(s) in the Tender and information given in Tender Document is considered as adequate.
